This program can provide free assistance on your Gas or Electric Utility Bills. It is designed to help income eligible households offset their heating and cooling costs. Priority is given to the elderly, disabled, and families with young children. You must meet the low income eligibility requirements. This program is funded by the Federal Low Income Home Energy Assistance Program through the State of CA, DCSD. If you qualify, a credit will be posted on your account.

TO ASSIST YOU, PLEASE PROVIDE THE FOLLOWING – YOU MUST ALL ITEMS BELOW:

- **CURRENT ELECTRIC BILL** (complete bill, all pages). Must cover at least 22 service days with meter reading.
- **CURRENT BLUE GAS BILL** (complete bill, all pages). Must cover at least 22 service days with meter reading.
- **PROOF OF CURRENT MONTHLY INCOME** Income for **everyone** that receives income in the household. Must cover the last **30** days.
- **VALID PICTURE I. D.**
- **SOCIAL SECURITY CARD**
- **CURRENT RENT RECEIPT, SEC 8 AGREEMENT, MORTGAGE STATEMENT, OR PROPERT TAX STATEMENT**
